


Figure 1. Key Characteristics of Educational Services

Let us examine the key characteristics of educational services (Figure 1):




Figure 2. Key Aspects of Enhancing the Role of Educational Services.

Let us explore the main aspects of enhancing the role of educational services under the conditions of the Third Renaissance and examine each of them (Figure 2):
