Tourist organizations are important in the development of MICE tourism. The role of tourist organizations is also high in knowing for what purpose they visited tourists coming to our country. We know that tourists visit any country for different purposes. While Kimdur visits for recreational purposes, kimdur visits again for business purposes. And MICE tourism is not mistaken to say that these two goals are

a combined form. Because while business people have visited for the purpose of holding conferences, forums, meetings in a variety of ways, it does not make it difficult to leave the country without traveling. MICE tourism will be able to provide you with such an opportunity.

To develop MICE tourism in Tashkent, we must first form an infrastructure that can meet modern requirements. To do this, it is advisable for us to find out what purpose the tourist MICE tourism is visiting our country. MICE tourism goals and types are travel that provides:

- holding talks or meetings with business partners;
- participation in professional events;
- establish, form and encourage relationships with new business partners;
- press tours;
- sending employees to train or improve their skills, forming a team and encouraging them. Facilities serving the development of MICE tourism include:
 - 1. Conference hall:
 - 2. Working offices;
 - 3. Event halls;
 - 4. Major shopping centers;
 - 5. Hotel halls;
- 6. Facilities where restaurants and similar cooperation meetings can be organized.

These tour operator companies are delighted with many tourists with their services. When organizing a conference in Germany, the average price per person can be set from US \$ 500 to US \$ 2,500. The total costs of the conference can range from \$150,000 to \$3,000,000. Again, it all depends on factors such as the size, location and duration of your conference. If you do not plan to serve any food, the cost of

holding the conference is usually US \$ 150,000, and the event will be designed for 250 people and will last two days. \$ 600 per person. The organizers of the event will benefit greatly from this. Because the higher the cost,the higher the income. In addition to the fact that the cost spent on organizing a mass event is self-sufficient, it requires economic beneficiation in the form of net profit².

Public events according to the definition of goals and the selection of the concept:

- ▶ party nights;
- ► charity shares;
- ► concerts, tours;
- ► exhibitions and fairs;
- business negotiations, political dialogues;
- > sports festivals, championships and cup competitions.

As can be seen from this picture, when organizing an event, it is necessary to initially determine the name of the event, focus on what purpose the event is organized, clarify the organizers of the event, determine the time of the event, use massmedia to promote the event or not? It will be necessary to clarify this, prepare the necessary technical means for the event, determine who the visitors are, determine the location of the event, pay special attention to the design of the event, attract partner organizations as much as possible to the event, maintain financial accounting. The creation of a plan for organizing conferences involves processes that are difficult for
