Abstract. This scientific article discusses the governing bodies and the pedagogical council of the education system in Uzbekistan.

Key words: Law "On Education", Cabinet of Ministers, pedagogical council, general secondary educational institution, pedagogue, education and upbringing.

Any social or collective work of any scale needs a manager to some extent. Therefore, just as each direction has a manager, there is a management system in the field of education.

The management of an educational organization is carried out by the following, respectively:

pedagogical council;

supervisory (trustee) council;

council of a higher educational institution;

head of an educational institution.

Public management bodies can be established in educational organizations.

Articles 23-24-25-26-27-28 of Chapter 3 of the Law "On Education" specifically talk about the management of the education system and list the bodies that manage the education system. There are 9 bodies that manage the education system in Uzbekistan:

1. The Cabinet of Ministers of the Republic of Uzbekistan;

2. The State Inspectorate for State Quality Control under the Cabinet of Ministers;

3. President, Agency for the Development of Creativity and Specialized Schools;

- 4. Authorized state management bodies in the field of education:
- a) Ministry of Preschool and School Education;
- b) Ministry of Higher Education, Science and Innovation;



- 5. Local government bodies;
- 6. Pedagogical Council;

7. Supervisory (trustee) Council;

8. Council of Higher Education;

9. Head of the educational organization.

In addition to these, we can also mention the public administration (trade union), but it is kept in a voluntary status.

Pedagogical Council. The Pedagogical Council is the highest body that discusses with the team the main issues related to the activities of a general secondary educational institution (hereinafter referred to as a general educational institution), and constantly works on the development of the educational process in a general educational institution and all organizational issues related to it.

The pedagogical council:

- directs the pedagogical team to improve the quality of education for students;
- hears reports from pedagogical staff on their areas of expertise;

• discusses and gives final conclusions on issues related to the health and life of students and other issues;

• carries out a number of tasks, such as studying the work experience of advanced teachers, recommending them for state awards, and organizing methodological assistance to young teachers.

The director, deputy directors and pedagogical staff of a general educational institution form the pedagogical council, and each pedagogical employee of the institution is a member of the pedagogical council from the moment of employment. The pedagogical council meeting is held at least once a quarter. Extraordinary meetings may be held if necessary.

The director of a general educational institution is the chairman of the pedagogical council. The secretary of the pedagogical council is appointed from among the pedagogical staff. In cases where the chairman of the pedagogical council is unable to
