When diplomats communicate with individuals from different cultural contexts, misinterpreting contexts can have serious consequences. Mastering Diplomatic English enables individuals to write clear formal messages, conduct meaningful conversations, and contribute to global peace and cooperation.

English for Specific Purposes (ESP) and its effects on international relations:
