In particular, he took measures to improve the road and communication sector. Amir Temur himself writes about this in "Tuzuklari Temur": "In every city... I ordered to build rabots (caravans) on the road for travelers and foreigners, and to build bridges over the rivers." "And I also ordered that observers and officers be appointed on the road to guard the roads, watch passers-by, merchants, travelers, and deliver their property and other things from address to address". Thanks to such orders of the ruler, the road and communication system in the country has developed a lot, trade has flourished. Despite the large territory of Amir Temur's state, security was ensured at a high level. It was possible to get safely from one corner of the country to another. However, the intermediate distance was a month's journey in Otarava. The roads also met the requirements for that period. The most important thing is that many caravanserais have been built along the roads to serve passengers. After all, the main means of transportation in those days consisted of animals such as donkeys, horses, and camels, and their associated carts. Passengers and caravans have been on the road for several days, months, or even years. They had to stop, rest and gather strength. The presence of caravanserais was the same provision for passengers. Otherwise, they will get exhausted and it is questionable whether they will reach the intended destination.

These opportunities created in the state of Amir Temur in terms of road and communication attracted foreign merchants. All conditions have been created for foreign ambassadors and trade people. At that time, many foreign countries established diplomatic and trade relations with the state of Amir Temur. We can cite the famous and famous Spanish ambassador and merchant Clavijo's trip to Amir Temur's country and the information he wrote down in his diaries as a vivid example.

One of the great merits of Amir Temur was that he revived the "Great Silk Road", which was declining in importance. Taking into account the potential of Samarkand in international trade, it expands the market in the city.

The plan for the development of cities on international trade routes was a far-sighted strategy of Amir Temur, the main goal of which was to turn Movarounnahr into an international trade center.

However, unfortunately, after the death of Amir Temur, along with the disintegration of his empire, the road and communication system he had restored and developed also suffered. Amir Temur's noble plans to turn Movaroonnahr into a developed, prosperous country were thwarted by his successors and other rulers. Especially during the period of the three khanates in the 18th-19th centuries, Central Asia became very prosperous. Bukhara, Kheva and Kokan khanates were backward in every respect. The level of social and economic development of the Khanate lags behind that of many countries of the world. Along with this, the road-communication system in the khanates was left to its own devices, and the roads and bridges were in a bad condition. Road and communication issues were almost ignored by the khans. Inventing or importing modern vehicles was not even thought of. All this ultimately led to the region sinking into the mire of backwardness and later being occupied and colonized by the Russians.

All spheres, including transport and communication systems, are integral areas of social relations. Communication issues have accompanied mankind since ancient times. Rather, it played an important role in the survival of primitive people. A large number of roads, the existence of an acceptable communication system are as necessary for cities as water and air. This centuries-old historical fact in the development of human society

has not lost its importance even today. Even now, in the modern world, the issues of road and communication maintain their priority.
